# **ABOUT WEST**

Hammersmith & Fulham (H&F) is a London Borough of wide disparities, with an acute need for youth services. This vast difference between those living in different parts of our borough can lead to radically different life outcomes. **WEST Youth Zone** is a vital provision that will make a huge impact on the lives of young people, and on the whole borough, levelling the playing field for our young people.

"WEST" Youth Zone, named Where Everyone Sticks
Together by local young people, opened on April this year. At
WEST, we believe all young people in West London should have
the opportunity to discover their passion and their purpose and
be able to explore where it can take them.

Our Youth Zone is a purpose-built space fizzing with energy and crammed with incredible facilities. Staffed by talented, skilled and dedicated youth workers who truly believe in young people, helping them see what they could achieve, and giving them the skills, confidence and ambition to go for it.

Open 7 days a week, while schools are closed - that's evenings and weekends, plus all through the school holidays. We offer a **safe and active space for young people** to flourish in their leisure time, where their interests can be nurtured, and they can grow as individuals. This is a charity that the whole community can be proud of, and you can be part of that journey.

We give 8 to 19-year-olds, (and up to 25 for young people with additional needs) affordable access to a broad range of sport, arts and mental health support, and employability services, designed to empower them to lead healthier, positive and more active lives – raising their aspirations for themselves and their community.



# THE ROLE

Alongside providing support and care to children and young people with special educational needs (SEN) and disabilities, SEN/D Youth Worker also help with the children's engagement in WEST's Arts, Sports, Wellbeing, and Lifeskill focused activities. The main duties of SEN specialists include:

- Identifying any learning difficulties a child may have so they receive the right support
- · Observing students' strengths and weaknesses
- Providing strategies to help and support each child
- Delivering interactive activities for young people in our Sensory room

Youth workers plan and deliver high quality youth work that supports young people in their personal, social and educational development. The role will require you to assist with Juniors (8 - 12 yrs) and/or Seniors (13 - 19 yrs) and/or Beyond (members with additional needs up to 25 yrs).

# **CORE RESPONSIBILITIES**

- To become part of a forward thinking, innovative and motivated team and assist with the delivery of all aspects of the youth zone sessions with young people.
- To work well in a team assisting the youth workers to work with young people showing signs of challenging behaviour.
- To motivate, encourage and support young people to try activities and participate fully in sessions.
- · To become part of sessional staffing requirements for the youth team department.
- To support volunteers on sessions, coaching them to achieve their full potential within their given roles
- To deal with any problems that arise during Youth Zone sessions.
- Develop and maintain a professional relationship with the young people who attend WEST Youth Zone.
- To adhere to WEST Youth Zone Youth's mission and deliver high quality youth work that supports young people in their personal, social and educational development.
- Comply with all policies, procedures, and codes of conduct, with particular reference to Safeguarding, Health & Safety, and Equality and Diversity.
- Understand the needs of WEST Youth Zone and communicate them in a clear, consistent way to the young people, parents and guardians.
- Work within the performance framework of WEST Youth Zone and OnSide.
- Represent WEST Youth Zone positively and effectively in all dealings with internal colleagues, and external partners.
- To be alert to issues of safeguarding and child protection, ensuring the welfare and safety
  of Youth Zone members is promoted and safeguarded, and to report any child protection
  concerns to the designated Child Protection Officers using the safeguarding policies,
  procedures and practice (training to be provided).
- To assist with any promotional activities and visits that take place at the Youth Zone.
- To actively promote the Youth Zone and positively contribute towards increasing Youth Zone membership.
- Any other duties that may be required
